1. INTRODUCTION

This guide presents the COLCX program fees for the certification of a mitigation initiative that seeks to be registered in the program, as well as for the certification of the GHG reductions or removals achieved, resulting in the issuance of the corresponding carbon credits.

2. APPLICABLE FEES

2.1 General aspects

For the COLCX Program, the milestones within the certification process of a mitigation initiative and its results that generate a charge are listed in the COLCX Procedure for the Mitigation Initiative Cycle. These milestones are achieved in compliance with the requirements stipulated by the COLCX Certification Program, the COLCX Standard for Certification of Mitigation Initiatives and the COLCX Standard for Validation and Verification.

2.2 Chargeable milestones in the COLCX program

The charges established in this guide are generated by:

- Conversion of carbon credits to COLCERs.

The registration of a mitigation initiative or the withdrawal of the COLCERs will only be effective when the totality of the amounts corresponding to the generating milestone has been paid within the times stipulated in the respective invoice issued by the program.

All payments must be supported to the program by sending the support of the bank transaction made in favor of the program, clearly identifying the initiative to which it corresponds, and the concept paid.

2.3 Current fees

For 2025, the fees applicable to the COLCX Program are as follows:

Process milestone	Applicable fee	Time for payment
Conversion of carbon credits to COLCERs	\$450 COP + IVA /tCO ₂	Depending on negotiation

*Value defined on the amount of GHG reductions or removals that the mitigation initiative estimates to generate annually and that will be credited to the first withdrawal or transfer of COLCERs.

3. FINAL CONSIDERATIONS

3.1 Independence

- COLCX's role is to issue certifications recognizing GHG reductions or removals achieved by projects enrolled and registered in the program.

While COLCX reviews and approves projects for certification, it does not participate in their design, development, monitoring, validation or verification, nor in the trading of the carbon credits generated by these initiatives. This approach guarantees the program's independence and impartiality, consolidating its position as a reliable player in the markets.

- This guide will be updated annually or sooner as deemed necessary by the COLCX Program in consideration of the applicable context.
